By purchasing from, using or visiting this website, product, software, data feed, or service provided to you on, from, or through this website https://proxym.in/, you represent and warrant that you are 18 or older, and you agree and acknowledge to be bound by these Terms of Use. If you do not agree to these Terms, please do not access the Site or use the Services. The Company reserves the right to change these Terms at any time. We recommend that you periodically check this Site for changes.
